EXAMPLES OF PBL COURSES INCLUDE COMPUTER CODING CLASSES, ENGLISH WRITING, CIVICS, THE GRAPHIC NOVEL, BIOLOGY CLASSES IN MAIZE AND MALERIA, AND DNA GENETICS. OTHER PROGRAMS INCLUDE CLUBS, SPORTS ACTIVITIES AND NUTRITIOUS FOOD FOR THE STUDENTS. FINALLY, WE HAVE BUILT AND MAINTAIN LIBRARIES AT BOTH TUMAINI JUNIOR SCHOOL AND TUMAINI SENIOR SECONDARY SCHOOL.
